### Internet & Wireless (January 22, 2024)

The Springvale Public Library is dedicated to providing free and equal access to information through technology, as this service is fundamental to supporting continuous, lifelong learning for people of all ages.

In order to comply with USAC's most recent interpretation of the Children's Internet Protection Act (CIPA), we use filters to block pornography and "harmful" material.

Users should exercise good judgment in accessing sites as they are not always accurate or secure, and even with filters, users may find sites that are disturbing, offensive or illegal. Springvale Public Library's electronic resources are all in a public area and may be used only for purposes that are legal and consistent with the Library's mission.

Therefore, users may not:

- View, display, print, distribute, or receive images, text or graphics of sexually explicit materials, child pornography or material that might be deemed "harmful to minors" as defined by law
- Libel, harass or slander other users
- Commit fraud
- Solicit minors
- Hack or spam
- Engage in illegal activities
- Harass other library patrons, computer users or staff, or make unauthorized use of files, data, passwords or accounts of others

Computer use:

- Patrons must sign in at the desk to secure a time slot.
- Length of use of a computer is at the discretion of staff members
- No more than 2 persons per computer
- Parents are responsible for establishing and enforcing family computer use guidelines for their minor children. Copies of guidelines for child safety on the Internet are available at the Children's Room desk. Adults must accompany young children when they use the workstations. Children under 14 must use the Children's Room computers.
